Overview

Advancements in Web3 over the past eighteen months have led to an explosion of blockchain games creating new economies of scale. New game mechanics are opening ways for users and developers to monetize almost every part of the Metaverse, and the latest AR/VR technology is redefining immersion. Unfortunately, the rush to capitalize on this massive opportunity has overlooked several barriers that have led to a complicated and overall underwhelming experience.



Problem

Blockchain technology in Web3 allows anyone to directly monetize their audiences, however the resources and infrastructure needed to support this new "creator economy" are not easily accessible. Further, the skilled Web3 developers needed for blockchain gaming cannot keep up with the rate at which gamers are crossing over, creating poor user experiences and a highly fragmented ecosystem.

Solution

The Kirin Creator Studio, a technical and economic infrastructure in the Kirin Metaverse, solves these issues by using AI and Machine Learning to create and mint interoperable avatars and user assets in a users web browser. The Kirin Creator Studio's "No Code" Suite and "Text to Render" generator will enable anyone to create their own virtual worlds. Kirin's proprietary data strategy and advanced editing techniques provide the high-quality, scalability, and missing resources needed to solve the developer deficit the industry is currently facing.



Learn To Earn (L2E)

With "education" being one of the greatest barriers to entry in the cryptocurrency and blockchain industry, the Kirin Learn-to-Earn program will be offered to everyone. Provide your external wallet address, and rewards will be transferred for completing certain tasks.

Play To Earn (P2E)

Play-to-earn games uniquely pay players to dedicate their time and talent in return for native tokens. Often, these play-to-earn games require large upfront capital contributions that ordinary players cannot afford (just like real-life real estate or industrial assets). Kirin takes on that risk for the players and purchases assets within these game ecosystems, builds infrastructure and security to enable players to operate those assets, and provides incentives linked to the KIRIN token to promote strong yields and competition.

Move To Earn (M2E)

Move-to-Earn allows earning passive income in cryptocurrency for performing physical activities in the real world. With the Kirin Battle Suit, movement in the real world is organically combined with the virtual world. Special applications calculate the amount of physical activity of players and turn this data into real compensation. This allows users an opportunity to earn income from physical activity.




